 - Adult involvement in the criminal justice system
- Wisconsin Department of Justice
 - Violent Crimes including domestic abuse and sexual assault

Opportunities and Barriers

 The current analyses rely on reported data from administrative agencies which underestimates incidents not reported to law enforcement officials

 Data collection practices are often not uniform across the multiple jurisdictions


 Overcoming bureaucratic hurdles with sharing data across multiple systems

Create data dashboard that highlights the patterns of violence


• Enhance and strengthen data about gun ownership, safety, and use





Arrest Rate of Violent Crime, 2015-2020




Trends in Violent Crime Arrest Rates by Offense




Trends in Domestic Abuse in Dane County

Incidents of Domestic Abuse, 2013-2018






