Roadmap Vision

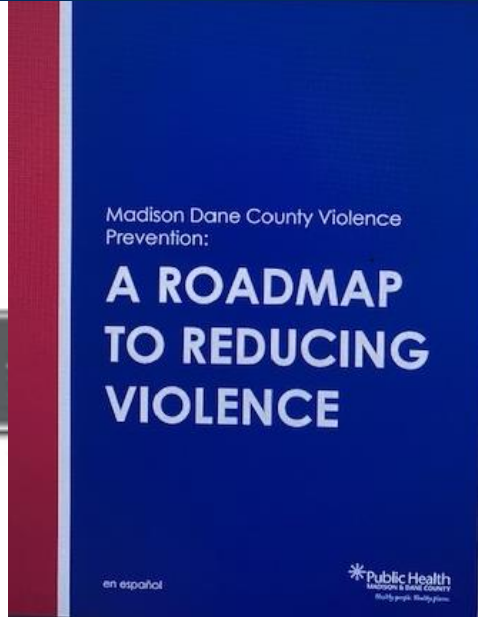


A community that utilizes collaboration and coordination to reduce violence and invest in the safety and health of residents and their environments

October Meeting Feedback and Commitment to the Process:

- Goals
 - What are the goals of the coalition and how will the Roadmap inform this work?
- Data
 - How can we incorporate violent related incidents from sources not captured from law enforcement?
- Evaluation
 - How will we measure the success of the workgroups and coalition?

Funding and Timeline:

Overview – the American Recovery Program Act (ARPA):

- ARPA/SLFRF--No sole source
 - \$1.5 million from City/County combined for Violence Prevention
 - Funding is to support PHMDC violence prevention infrastructure and to support the work of the Coalition.
 - The goal is to maximize the amount of funding available through RFP
 - Spending through June 2024
- Competitive RFP(s) issued by PHMDC to address priorities of Work Groups
 - Plan to issue RFP(s) in April 2022
- A funding FAQ document is under development and will be shared with the workgroups in an upcoming meeting

MDCVP Coalition Workgroup Action Plan Updates:



Data Workgroup Action Plan Activities

Strategy 1:

- Use timely, comprehensive data to prioritize and implement prevention efforts

Objective 3:

- Enhance local capacity to collect, access, analyze, and utilize primary and secondary mixed methods violence related data from a variety of sources, including people with lived violence experiences, local emergency depts., Emergency Medical Services (EMS), law enforcement, trauma informed care services, and medical examiners

Activities:

- Identify what types of violence the coalition will focus its efforts
- Identify what city/county agencies collect data related to violence and house in one central data warehouse
- Identify how organizations that provide services to victims of violence collect and document information on the clients they serve

Children, Youth & Families Workgroup: Action Plan Activities

Strategy 1:

- Expand intimate partner violence and sexual assault primary prevention programming to address shared risk and protective factors of violence

Objective 3:

- Adopt comprehensive school-based sexual violence and teen dating violence prevention policies and practices that also address the needs of LGBTQ youth

Activities:

- Exploring opportunities for existing high school student clubs (e.g. BSU, gender equity, Men's club) to collaborate on the development of consent curriculum and providing youth stipends to those involved

Children, Youth & Families Workgroup: Action Plan Activities

Strategy 3:

- Promote healthy families and quality early learning to foster culturally responsive, healthy child development

Objective 3:

- Support father-child connectedness, including opportunities for systems-involved fathers

Activities:

- Research & catalogue existing fatherhood initiatives in Dane County
 - Recruit & engage fathers in the work and provide stipends for their participation
- Determine the scope and funding needs of the work for 2022

Children, Youth & Families Workgroup: Action Plan Activities

Strategy 4:

- Increase employment and workforce development opportunities for youth

Objective 2:

- Develop re-engagement centers for young people ages 14-24 who have been disconnected from school and workforce to support skill development and reconnection to educational and employment opportunities

Activities:

- Exploring staffing funding and models for “reconnectors” helping transition youth between school and work and/or other education opportunities
- Exploring development of an app that would support awareness of reconnection places & send youth reminders

Intervention and Healing: Action Plan Activities

Combined Strategies 1,3,4: Housing and Violence

Strategy 1 – Objective 3: Strengthen referral systems and coordination among agencies that provide support and services to perpetrators, victims and those at risk of perpetration or victimization of violence

Strategy 3 – Objective 5: Work to address service access and coordination **barriers** stemming from **homeless or housing insecure** status of participants

Strategy 4 – Objective 4: Create streamlined referral systems to services, crisis intervention, and treatment to address trauma experienced by survivors

Activities: Action Plan and Recommendations

- Map out current services
- Risk and protective factors
- Barriers, housing policies
- Intersection with violence
- Tenant's rights/state laws
- Healing/Long-term trauma and recovery

Fostering Strong Neighborhoods:

Strategies:

Engage people in visioning the physical spaces that support safety, joy, and wellbeing

Resource neighborhoods and people towards this vision.

Activities: Action Plan and Recommendations

- **Community Engagement Process**
- **Gather feedback from community members and stakeholders regarding components of Neighborhood Safety**

Coordination Workgroup Action Plan Activities

Strategy 1:

- Support opportunities for violence prevention capacity building and increased collaboration across organizations and sectors

Objective 3:

- Identify and collaborate on strategies to support violence prevention policy development, advocacy and implementation

Activities:

- Mapping Services & Resources – Service Provision Survey
- Increase & support coordination & cross-collaboration
- Examine data with Data Work Group
- Identify gaps, risk and protective factors
- Support funding and resource development (Strategy 2)

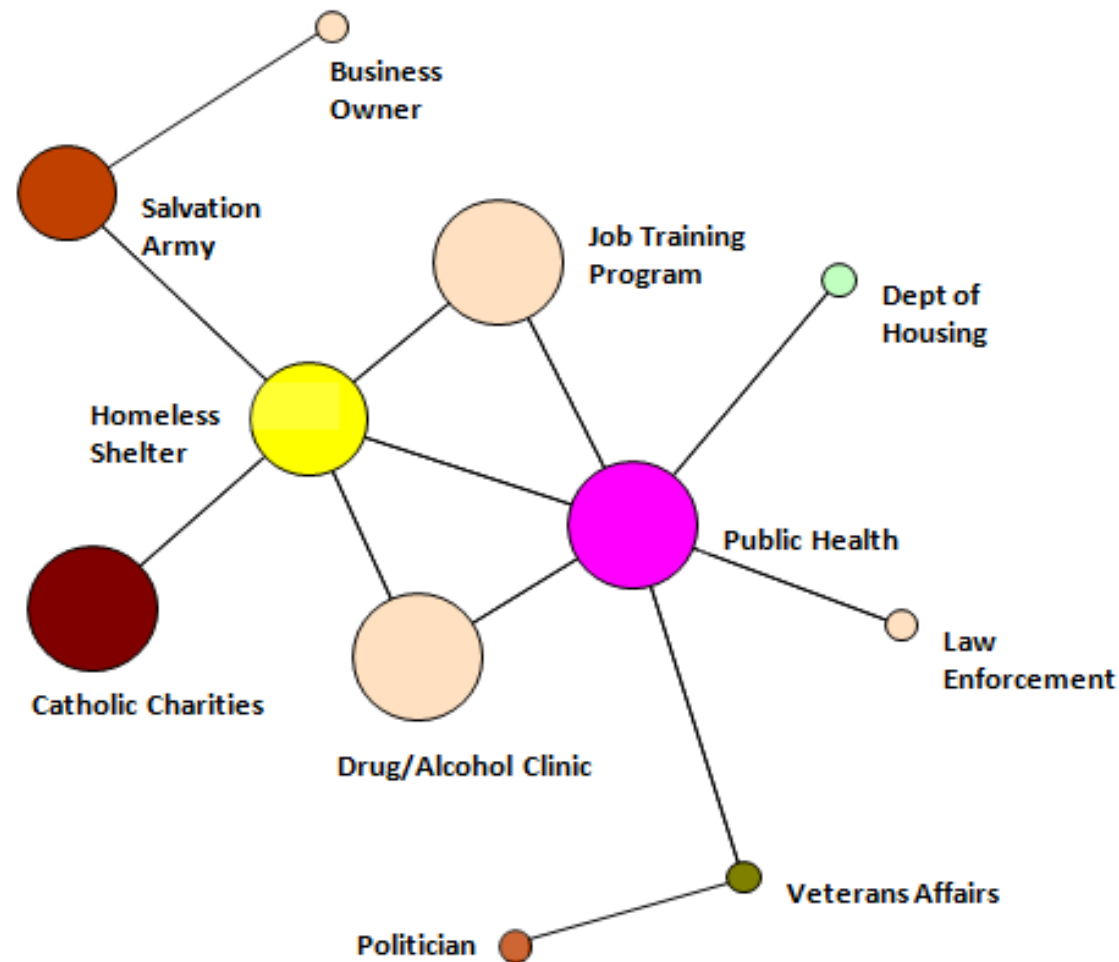


Service Provision Survey + Data

- Data Sharing - why
- Capture a wide range of data about challenges in communities with the goal of improving community conditions
- Lays the groundwork for the coalition to identify how service providers are supporting community and how they are documenting their work
- Allow us to collaborate and identify how to develop strategies and interventions to address systemic challenges

MDCVPC Organizational Network Analysis (ONA)

Organizational Network Analysis

What?

- Coalition exists because no one organization can solve violence by itself; we need coordination and collaboration
- Measure strength of existing relationships among partner organizations
- Identify assets that partners bring to the coalition (beyond services to clients)
- Anticipate benefits of the coalition

Organizational Network Analysis

Why?

- Strengthening relationships will enable us to effect change to the existing dysfunctional systems of violence
- Measuring the strength of relationships enables us to:
 - Identify sectors or organizations that might be missing
 - Target our energies to strengthening particular relationships
 - Measure changes over time

Organizational Network Analysis

Steps

- PHMDC staff drafts ONA survey, get coalition members' input; revise survey
- Each coalition member organization completes ONE survey
- Staff analyze and visualize results; coalition input to make meaning
- Coalition uses results for planning
- Repeat survey to assess changes
